# **EU-TR COOPERATION LOGO**

The European Union-Türkiye Cooperation logo is the common element used as a symbol in all projects financed by the European Union. Whatever the size, scope or objective of a project, The European Union-Türkiye Cooperation logo must be prominently displayed.

The European Union-Türkiye Cooperation logo consists of the flags of the European Union and Türkiye side by side as shown below:

EU - TR Cooperation logo should be followed by the following text:

"Avrupa Birliği tarafından finanse edilmektedir" (Turkish).

"Funded by the European Union" (English)

There should be no text under any other logo.

Only The European Union-Türkiye Cooperation Union logo should have the above-mentioned



#### How to use


All materials you produce within the scope of the project must have The EU-TR Cooperation logo and phrase at the top. It should be enlarged and reduced in its original size.



#### **Colours**

Below are the colour codes of the Turkish flag and the flags of the European Union.

- "Pantone Reflex Blue" for the background of the rectangle,
- "Pantone Process Yellow" for stars



# **EU-TR COOPERATION LOGO**

#### **Turkish Flag**

The Turkish Flag must also be used appropriately on visibility devices and in accordance with the Turkish Flag Law No. 2893 published in the Official Gazette (Date: 24/9/1983 No.: 18171).



#### **Backgrounds**

The EU-TR Cooperation logo should preferably be printed on a white background. Multi-coloured backgrounds should be avoided, especially backgrounds containing a colour that does not match blue. If a coloured background cannot be avoided, it should be surrounded by a white border with a thickness of 1/25 of the height of the rectangle.

# Republic of Türkiye Ministry of Treasury and Finance Central Finance and Contracts Unit Logo (CFCU)

In all printed and digital works, the CFCU logo must be in the lower left corner.





# Logo of The Republic of Türkiye Ministry of Environment, Urbanization and Climate Change

All printed and digital works must have the CFCU logo on the right side.





#### **Union of Provinces Logo**

It should be placed on the right side of the programme logo in all printed and digital works.



#### Republic of Türkiye Ministry of Foreign Affairs Directorate for EU Affairs Logo

In all printed and digital works, the logo of the Union of Provinces should be on the right side.




#### The Union of Municipalities of Türkiye Logo

Logo arrangement, heights should be the same.



CFCU and Union of Municipalities of Türkiye, Ministry of Foreign Affairs Directorate for EU Affairs, The Union of Provinces, Environment The Ministry of Urbanisation and Climate Change and the Programme logo can be found at the bottom of printed and digital materials in the first row, Coordinating Beneficiary, Co-Beneficiary logos below them (in the second row) must be included. The logo of the Coordinating Beneficiary and the logo of the Co-Beneficiaries must be displayed on the CFCU and other

The logos of the implementing partners are vertically half of the EU-Türkiye Cooperation logo should be large.



The use of logos in all printed and digital materials should be as above (posters, brochures, flyers, rollups, banners, social media covers and social media news templates, etc.).

Grant Implementers are required to use their "Project Names", if any, and "Project Logos" in printed and digital media in accordance with the visibility rules.



#### **Social Media and Website**

Social media accounts should have the "European Union - Turkey Cooperation logo" and "Funded by the European Union" on the cover.

Grant implementers should use the "**Project Name**" in printed and digital materials. If they have a "**Project Logo**", they should also include it.

Logos of Other Institutions should be placed at the **bottom row** of the visuals, and the logos of the Coordinating Beneficiary and Co-Beneficiary should be placed in the **second row below** them. The logo of the Coordinating Beneficiary and the logo of the Co-Beneficiaries should be at the **same height** as the logos of the CFCU and other institutions.

The disclaimer must also be included.


